<u>DECLARATION AND UNDERTAKING</u> OF A STUDENT CANDIDATE / CONTINUING STUDENT

- 1. I, the undersigned, hereby apply to be accepted / continue as a student at Bar Ilan University. I am aware that registration fees, entrance exam fees, and the like, are not refundable.
- 2. As part of my application to be accepted for study at the University, I provided the University with personal and other details needed to examine my candidacy for the University and/or studies at the University and to contact me. I was also given the option to provide, at my choice, additional details which there is no legal obligation to provide, for optional purposes such as scholarships, adjustments, and the like. I was informed that the details provided by me will be stored in the University's databases. I declare and undertake that all the details provided by me are correct and complete, and agree that the University may perform checks and obtain details for the purpose of verifying the truth as well as take disciplinary or other measures, including cancelling registration, stopping studies and cancelling eligibility for a scholarship retroactively, in the event of the provision of false and/or misleading data.
- 3. I undertake to keep up-to-date with all the University's instructions and by-laws, which are published on the University's website at www.biu.ac.il as well as in the information leaflets published by the University, and the notifications sent to students, including by e-mail. I am aware that the instructions, by-laws and notifications are binding on me and I undertake to comply with them, throughout all my years of study at the University.
- 4. I am aware that the format of studies, including exams, will be determined by the University in accordance with academic requirements, legal provisions, circumstances connected to the Corona crisis and exigencies ensuing from the fact that the studies and examinations may require physical presence, be conducted online, require a combination of the two, or be conducted in any other suitable way, including through the use of appropriate technological measures, as determined by the University.
- 5. I undertake to pay the tuition fees, mandatory student payments and related payments, as well as any amount imposed on me in accordance with the University's instructions, on time. I agree that arrears in payment(s) will give rise to linkage differences and arrears fees at a rate that will be published on the University website, and will also allow the University to take measures such as blocking services, refusing to issue confirmations of studies and termination of studies, in accordance with its instructions in this regard. Receiving a degree, recognition or academic approval will not derogate from my obligation to pay the balance of my debts to the University. I am aware that welfare payments are optional payments and that if, by the appointed time, I do not notify my choice not to make welfare payments, I will be charged their payment as an inseparable part of the tuition fee.

- 6. I am aware that a termination of studies will come into effect only if and when the student's notification of this arrives in writing through the student personal information system "In-Bar" "Requests and authorizations", and I undertake to act accordingly.
- 7. Clicking "Confirm" on an electronic form on the University's website will bind me, as if I had made the confirmation in writing.
- 8. I am responsible for all University property that comes into my possession or that I use. I will notify the University immediately of any damage to the aforesaid property or its loss, and I will pay to the University any sum / compensation / fine due to the damage / delay in returning it, in accordance with instructions.
- 9. I am aware that the goals and aspiration of the University is to foster and promote learning and research in all branches of Torah and science in the spirit of Israel's Torah and heritage. The University does not intervene in a person's faith and opinions, but it expects all who enter its precincts to behave respectfully to the institution and to others and I undertake to behave in a way that respects the customs of the University and to comply with the accepted arrangements arising from the University's special nature.
- 10. I give my consent for my name to be included in the lists of courses, students and graduates to be published by the University. I am aware that upon completion of my studies, my details will be stored in the graduate database of the University for the purpose of documentation and maintaining contact.
- 11. The details that I provided to the University will be used for my studies at the University and for contact between me and the University, including transmission of information on behalf of the University by means of electronic messages and SMS's regarding study programs and courses, scholarships and awards, activities at or on behalf of the University, among them enrichment activities, culture and leisure, student services and benefits. I am aware that I may, at any time, notify my removal from the mailing list of messages consisting of advertisements, by selecting the appropriate option appearing at the bottom of those messages.
- 12. I agree to the transmission of my personal information to the National Insurance Institute, in order to apply a discounted rate for students.
- 13. I agree to the transmission of my personal information to the Council for Higher Education as well as to non-commercial entities, whose objective when making contact is to contribute to the welfare of the student, for example, by giving grants or scholarships.
- I am aware that some of the services to which the welfare fee payers are entitled are provided by the Student Union, Bar Ilan University (R.A.) (hereafter: the "Student Union"), and that for this purpose the following details of the welfare fee payers are transmitted to the Student Union: full name, ID number, study groups, email address and mobile phone number.

- 15. My declarations and undertakings above and below refer to all years of study at the University, and various annual registration activities such as assembling study courses, registering for courses, etc. will not derogate from them nor prejudice their validity.
- 16. I agree that the University may receive from any source, any information about my past studies, including all my grades, including in matriculation exams, psychometric exams, academic studies, certification studies, etc., subject to the fact that the University will store the information in accordance with the provisions of any law and not make any use of it save in respect of my candidacy and studies in it, or for purposes of research and statistics. Likewise, I agree that the University may transfer information about my academic achievements to the National Institute for Testing and Evaluation (A.R.), for research purposes.
- 17. The courts in the Tel Aviv District are vested with exclusive local jurisdiction regarding any claim between myself and the University.
- 18. I agree that the University may receive my matriculation grades from the Ministry of Education, or from anyone authorized by it, for the purpose of examining my application to be accepted for study at the University, and this by any means of storage of data, as may be agreed between the University and the Ministry of Education, and subject to the University's undertaking that no use will be made of my grades save for the purpose of my acceptance to the University, and that it will take all the measures necessary to safeguard the data and prevent its transmission to others.
